This Financial Report of Stichting EndPlasticSoup is made up in respect of the period of 1 July 2022 to 30 June 2023and so it follows the Rotary International financial year.

1. POLICIES

General

The accounting concept applied to the value of assets and liabilities is based on historical costs. Revenue and expenses are allocated to the period to which they are realised.

Reserves and funds

The reserves consist of free disposable capital and designated reserves. Designated funds are funds that are allocated to specific activities by specific donors.

Legal status

EndPlasticSoup is registered as a stichting ('foundation') under Dutch law. Its Articles read that, in line with Rotary International, the financial year runs from July 1st to June 30th; the Treasurer prepares, and the Board approves and publishes, a balance sheet and profit and loss account within six months after year end.

ANBI status

Stichting EndPlasticSoup enjoys the tax status of an *Algemeen Nut Beogende Instelling* (ANBI) ('Public Benefit Institution') under Dutch law providing the possibility of tax benefits to its Dutch corporate and private donors, whilst imposing certain reporting requirements on the foundation.

6. NOTES to the STATE OF INCOME AND EXPENSES

The operating result of the financial year 2022 - 2023 before allocation amounts to (a satisfying) minus €246.

The remainder of the originally €35,000 Designated Funds originated from the successful fundraising action of RC Winschoten (D1590, The Netherlands; the club developed a Rotary jigsaw puzzle and selected EndPlasticSoup as the destination for the proceeds of the sales!) in the of amount of €9,250 was disbursed to the Education Visitors Centre site.

The projects supported by EndPlasticSoup were numerous, the most noteworthy being:

- the Bye Bye Plastic Bags project in Bali (Indonesia) facilitated by RC Brühl (D 1810, Germany); and
- the España Azul project in Spain and the ongoing support for the Education Visitors Centre at Katwijk (The Netherlands)

Also noteworthy are the donations to support the Young Ambassadors, our initiative to attract younger generations.

7. Stichting EndPlasticSoup

On June 1, 2018 the EndPlasticSoup initiative started off with eight Rotary Clubs from Amsterdam. By the end of June 2023 EndPlasticSoup had [316] Supporter Clubs and [81] Ambassador Clubs, overall an increase of 22 clubs. Club donations equalled (conservative) forecast despite, however, new clubs joining a slight increase from the previous year only; not all clubs paid their annual fee regularly. We have improved our accuracy in sending invoices and henceforth EndPlasticSoup will be sending invoices and midterm reminders, so as to achieve a meaningful increase in club donations. Stable donation revenues from the Rotary Clubs are key to our being a serious player in the field. And our growth makes clear we need more budget to fulfil the ambitions of EndPlasticSoup. We see an overwhelming interest in the EndPlasticSoup initiative worldwide and, in order to support the growing number of projects and actions, we need to continue to carefully manage our income and expenses and look for new sponsors and additional fundraising.
